S1. Ans.(d)

Sol. The Udaipur Science Centre, at Udaipur, Tripura was dedicated to the people by the Governor of Tripura, Ramesh Bais on February 28, 2021. Minister of State (Independent Charge) for Culture and Tourism, Govt. of India Prahlad Singh Patel, was the Chief Guest on the occasion.

Sol. The State Bank of India (SBI) Mutual Funds has launched its first overseas offering on 1 March 2021. The fund titled SBI International Access — US Equity FOF is an open-ended fund of funds scheme investing in mutual fund scheme/ETFs that invest in US markets, which are domiciled overseas.

Sol. The World Bank plans to introduce a \$100-million credit guarantee scheme to boost India's rooftop solar programme, which has not gained enough traction. The scheme will allow micro, small, and medium enterprises (MSMEs) to avail concessional debt financing for setting up rooftop solar units.
