### NOTICE

1. Results of Online Preliminary Examination is being made available to the candidates.
2. Online Main Examination is expected to be conducted on 22.01.2022. Provisionally Shortlisted Candidates for Online Main Examination are advised to regularly keep in touch with the authorised IBPS website [www.ibps.in](http://www.ibps.in) for details and updates.
3. Call Letter of Preliminary Exam was not collected at the time of examination. Shortlisted candidates will be required to bring the duly authenticated/ stamped preliminary exam call letter (along with authenticated/ stamped copy of the ID proof) along with Main Exam call letter and other requisite documents as per information provided in the "Information Handout" and call letter.
4. All documents as prescribed in the advertisement and/ or call letter should be produced without any exception at the time of Online Main Examination
5. The candidate's identity will be verified with respect to his/her details on the call letter, in the Attendance List and requisite documents submitted. **If identity of the candidate is in doubt the candidate may not be allowed to appear for the Online Main Examination.**
  - **Ration Card and Learning Driving License will not be accepted as valid id proof for this process.**
  - **In case of candidates who have changed their name, they will be allowed only if they produce original Gazette notification / their original marriage certificate / affidavit in original.**
6. Biometric data (Right thumb impression or otherwise) or IRIS Scan and photograph of the candidate will be captured during Online Main Examination at the venue. Decision of Biometric Data/IRIS Scan verification authority with regard to its status (matched or mismatched) shall be final and binding upon the candidates. **Refusal to participate in the process of biometric data/ IRIS Scan/ photograph on any occasion may lead to cancellation of candidature.**

**With regards to the biometric data capture, please note the following:**

- a) If fingers are coated (stamped ink/mehndi/coloured...etc.), ensure to thoroughly wash them so that coating is completely removed before the exam day.
- b) If fingers are dirty or dusty, ensure to wash them and dry them before the finger print (biometric) is captured.
- c) Ensure fingers of both hands are dry. If fingers are moist, wipe each finger to dry them.
- d) If the primary finger (Right thumb) to be captured is injured/damaged, immediately notify the concerned authority in the test centre.

In such cases impression of other fingers, toes etc. may be captured.

**With regards to the IRIS scan, please note the following:**

- a) 'LEFT EYE (IRIS)' will be captured for all the candidates.
- b) Candidates should remove Contact Lenses and Spectacles while capturing IRIS. Candidates are advised to avoid wearing contact lenses and prefer spectacles.
- c) There is no touch involved in IRIS scanning. Half feet distance between scanner and eye will be maintained.

(Any failure to observe these points will result in non-admittance for the examination)

7. Candidates are advised for their own interest not to carry any of the banned items to the venue of the examination as detailed in Point K of the advertisement dated 19.10.2021.
8. Any unruly behaviour/ misbehaviour in the examination hall may result in cancellation of candidature/ disqualification from future examinations conducted by IBPS.
9. **Marks obtained only in the Online Main Examination will be considered for shortlisting for Interviews and Final Merit Listing.**
