1. While every care has been taken in preparing the list, however ESI Corporation reserves the right to rectify the errors/omissions, if any comes to its notice.
2. Since the applications for the above post were called online only and hard copy of application along with documents in support of their eligibility for the post were not called from the candidates, the candidature of all the candidates short listed for verification is purely provisional subject of fulfilment of eligibility criteria with regard to age, essential qualification and reservation etc.
3. The above candidates shortlisted for verification must bring all ORIGINAL documents in support of their eligibility for the above post at the time of verification. The date and time for verification along with necessary instructions will be uploaded on ESIC website www.esic.nic.in shortly and letters will be issued to all the above candidates shortlisted for verification in due course.
4. Candidates short listed for verification must ensure that they belong the respective category/sub category as mentioned in the above list.

5. Those candidates who are in Govt. Service (including ESIC Employees) are required to produce No Object Certificate (NOC) at the time of verification.
6. Candidates belonging to other categories/sub-categories are required to submit the requisite certificates in the prescribed proforma given in the Annexure-A to Annexure-G of the detailed advertisement.
7. Candidates seeking age relaxation as Government Employee/ESIC Employee shall have to produce Service Certificate at the time of verification.
8. In the detailed advertisement for the post of UDC, MTS & Steno. it has been notified that the facility of scribe shall be given only to persons with benchmark disabilities in the category of **blindness, locomotor disability (both arm affected-BA) and cerebral palsy**, if so desired by the person. For other category of persons with benchmark disabilities, the provision of scribe can be allowed on production of a certificate to the effect that the person concerned has physical limitation to write, and scribe is essential to write examination on his behalf, from the Chief Medical Officer/Civil Surgeon/Medical Superintendent of a Government health care institution as per prescribed proforma appended at Annexure – G of the advertisement.
As such, PWD candidates other than in the category of **blindness, locomotor disability (both arm affected-BA) and cerebral palsy**, who have availed services of scribe in the Phase I and/or Phase II Exam for the post of MTS are required to submit certificate regarding physical limitation to write in the prescribed proforma appended at Annexure – G of the advertisement.
