CONDUCT OF PHASE-II MAIN EXAMINATION FOR THE POST OF SOCIAL SECURITY OFFICER (SSO)

The Phase – II Main Examination for recruitment to the post of Social Security Officer (SSO) is scheduled to be held on 23rd July, 2022 (Saturday).

The **link to download Call Letter** for appearing in the Phase – II Main Examination for the post of SSO along with **Information Handout** (Hindi & English) are uploaded on the website of ESIC (www.esic.nic.in).

The candidates are advised to carefully read the instructions given in the Call Letter and Information Handout before appearing in the Examination. They are also advised to keep visiting ESIC website www.esic.nic.in for further updates/instructions in respect of above recruitment.

As per Govt. of India, Ministry of Social Justice & Empowerment OM F. No. 34-02/2015-DD-III, dated: 29th August, 2018 - "the candidate should have the discretion of opting for his own scribe/reader/lab assistant or request the Examination Body for the same."

As per above O.M. dated: 29th August, 2018 in case the candidate is allowed to bring his/her own scribe, the qualification of the Scribe should be one step below the qualification of the candidate taking examination.

In case it is found that the qualification of the Scribe brought by the candidate is not one step below the qualification of the candidate taking examination, the candidature of the candidate shall be summarily rejected.

Accordingly, PWD candidates appearing in the above examination are advised that in case they need the assistance of Scribe, they have the discretion of (1) Opting for their Own Scribe or (2) they can make a request (through email/telephone/written application/personal visit) to the ESIC Regional Office of the State in which their Exam. Center is situated for providing Scribe by 15.07.2022.

Candidates can also make a request via email/telephone at jd-rectt@esic.nic.in/Tel. No. 011-23219513 for providing Scribe by 15.07.2022.

The addresses and email ids of the concerned Regional Directors are appended below at Annexure 'A'.

Appended at Page No. 2 is 'Scribe Declaration Form' to be filled and submitted by the candidates using their own Scribe on the day of examination at Examination Center.

It is further informed that in the advertisement for the post of SSO. it has been notified that the facility of scribe shall be given only to persons with benchmark disabilities in the category of **blindness**, **locomotor disability (both arm affected-BA) and cerebral palsy**, if so desired by the person. For other category of persons with benchmark disabilities, the provision of scribe can be allowed on production of a certificate to the effect that the person concerned has physical limitation to write, and scribe is essential to write examination on his behalf, from the Chief Medical Officer/Civil Surgeon/Medical Superintendent of a Government health care institution as per prescribed proforma appended at Annexure – G of the advertisement.

IMPORTANT NOTE: No request for Change of Examination Center will be entertained by ESIC.
