RBI's Financial Stability Report, 2024

The Reserve Bank of India (RBI) has released its **Financial Stability Report (FSR)** for December 2024, providing a comprehensive analysis of the Indian financial system's health. The FSR is published **biannually**, typically in June and December, offering insights into the stability and resilience of the financial sector.

Key Highlights from the RBI Financial Stability Report, December 2024

- 1. Asset Quality of Banks:** The gross non-performing assets (NPAs) ratio of Indian banks has declined to a 12-year low of 2.6% as of September 2024. This improvement is attributed to recoveries, write-offs of legacy bad loans, and a reduction in the growth of bad assets.
- 2. Projections for NPAs:** The report projects that the gross bad loan ratio may rise to 3% by March 2026 under a baseline scenario, and could reach up to 5.3% under high-risk scenarios. Despite these potential increases, the RBI assures that no bank is expected to fall below the minimum capital requirement of 9% even in adverse conditions.
- 3. Economic Growth Forecast:** The RBI anticipates a GDP growth rate of 6.6% for the fiscal year 2024-25, indicating a positive outlook for the Indian economy following a slowdown in the first half of the fiscal year.
- 4. Liquidity Deficit:** The banking system is facing a significant liquidity deficit, which is expected to widen further in the upcoming quarter. As of December 23, 2024, the liquidity deficit stood at 2.43 trillion rupees, driven by tax outflows and the central bank's foreign exchange interventions. Market participants suggest that measures such as open market bond purchases and potential cuts in the cash reserve ratio (CRR) may be considered to address this issue.
- 5. Regulatory Compliance:** The report notes a 47% decline in monetary fines imposed by the RBI from June to November 2024, totaling nearly Rs 30 crore, compared to over Rs 57 crore in the same period the previous year. This decrease reflects improved regulatory compliance across banks and financial institutions.
- 6. Non-Banking Financial Companies (NBFCs):** The balance sheets of NBFCs have strengthened, with stress tests indicating that even under high-risk scenarios, their capital requirements would remain well above the minimum needed level.

Reserve Bank of India's (RBI) Report on Trend and Progress of Banking in India 2023-24

The Reserve Bank of India (RBI) has released the **"Report on Trend and Progress of Banking in India 2023-24,"** offering a comprehensive analysis of the banking sector's performance during the fiscal year 2023-24. This **annual report** provides insights into various facets of the banking industry, including asset quality, profitability, capital adequacy, and emerging challenges.

Key Highlights from RBI Report on Trend and Progress of Banking in India 2023-24

1. Asset Quality of Banks:

The gross non-performing assets (NPAs) ratio of Indian banks has fallen to a 12-year low of 2.5% as of September 2024, the lowest since 2012. This improvement is attributed to recoveries, write-offs of legacy bad loans, and more effective management of asset quality. The reduction in bad loans is reflective of better risk management and recovery efforts.

2. Projections for NPAs:

The report projects that the gross bad loan ratio could rise to 3% by March 2026 under a baseline scenario. In high-risk scenarios, it could reach up to 5.3%. While the sector anticipates some increase in NPAs, the RBI assures that banks will maintain sufficient capital and not fall below the 9% minimum capital requirement, even in adverse conditions.

3. Credit Growth and Economic Outlook:

The Indian banking sector has witnessed a significant 19% increase in credit growth during 2023-24, reflecting positive economic growth and robust demand for loans. The growth in advances is particularly strong in sectors like infrastructure, housing, and personal loans. The optimistic credit outlook is also indicative of an improving economic environment in India.

4. Digital Transformation in Banking:

The Indian banking sector has been undergoing a digital revolution, with an increase in online and mobile banking transactions. The launch of Central Bank Digital Currency (CBDC) pilots further highlights the sector's move towards embracing cutting-edge digital financial solutions. Digital banking continues to grow rapidly, helping increase financial inclusion and improving customer experiences.

5. Strong Capital Adequacy:

The Capital-to-Risk-Weighted Assets Ratio (CRAR) of Indian banks stood at 16.8% as of September 2024, significantly higher than the regulatory minimum of 9%. This indicates that Indian banks are in a strong position to absorb any shocks, with robust capital buffers ensuring financial stability.



6. Increasing Bank Frauds:

The report highlighted an alarming increase in bank frauds, with fraud-related cases seeing a significant rise in the first half of FY25. This trend is expected to continue, raising concerns about cybersecurity and internal controls in the banking sector. The RBI is likely to take measures to mitigate these risks going forward.

Detailed Analysis of each point

1. Asset Quality Improvement:

The banking sector has made significant strides in enhancing asset quality. The GNPA ratio's decline to 2.5% in September 2024 reflects effective recovery efforts and prudent lending practices. The reduction in Net NPAs to 0.57% indicates improved asset quality and better risk management.

2. Profitability Growth:

SCBs have demonstrated consistent profitability, with a RoA of 1.4% and RoE of 14.6% in 2023-24. This sustained growth underscores the sector's resilience and operational efficiency.

3. Capital Adequacy:

The CRAR of 16.8% as of September 2024 surpasses the regulatory minimum, ensuring banks have sufficient capital buffers to absorb potential losses and support growth.

4. Credit Growth:

The 19% increase in advances highlights robust credit demand, indicating confidence in economic recovery and expansion.

5. Digital Transformation:

The rise in digital banking transactions and the initiation of CBDC pilots reflect the sector's commitment to modernization and financial inclusion.

6. Emerging Risks:

The projected increase in the GNPA ratio to 3% by March 2026 and the rise in bank fraud cases necessitate enhanced risk management and vigilance.

ISRO Launches Historic SpaDeX Mission for Space Docking

India's space journey takes a giant leap as ISRO successfully launched the SpaDeX mission to demonstrate space docking capabilities, marking a key milestone in space exploration. Launched from the **Satish Dhawan Space Centre (SDSC SHAR)** on December 30, 2024, the **PSLV-C60 rocket** carried two small spacecraft, SDX01 (Chaser) and SDX02 (Target), to low-Earth orbit. This mission sets the stage for autonomous docking and undocking technologies, positioning ISRO as the fourth global player in this field after Russia, the US, and China.

Mission Objective and Technology

The primary aim of SpaDeX is to develop technology for rendezvous, docking, and undocking of spacecraft in low-Earth orbit. This includes:

Autonomous Docking: Demonstrating the critical ability to dock and undock spacecraft autonomously.

Power Transfer: Establishing energy transfer between the docked spacecraft, essential for future space applications like robotics.

Position and Navigation: Utilizing differential GNSS-based Satellite Positioning Systems for precise control and coordination.

Indigenous Technologies and Advancements

The mission highlights several indigenous technologies, including:

Docking Mechanism: An advanced docking system designed for high precision, crucial for small spacecraft.

Communication Systems: An inter-satellite communication link (ISL) enables real-time communication during orbital maneuvers.

Relative Orbit Determination: GNSS-based Relative Orbit Determination and Propagation (RODP) ensures precise positioning during docking.

Significance for India's Space Future

The successful SpaDeX mission not only boosts India's space capabilities but also lays the groundwork for complex future missions, such as satellite servicing, space station assembly, and lunar exploration. It strengthens ISRO's position in the global space community and offers a foundation for advanced space missions like **Chandrayaan-4**, which will operate without **Earth-based GNSS support**. With this mission, India moves closer to its vision of deep space exploration and technological leadership.

ECI Publishes Detailed Data for Lok Sabha and Assembly Polls 2024

The **Election Commission of India (ECI)** released comprehensive data for the **2024 Lok Sabha elections, including 42 statistical reports.** Voter turnout increased, with **64.64 crore votes polled**, a 7.43% rise in registered electors, and higher participation from women and third-gender voters. The number of **polling stations increased to 10.53 lakh**, and the number of nominations rose to 12,459. **Women electors now comprise 48.62% of the electorate**, and the number of female candidates contesting elections grew to 800. Inclusive elections saw significant increases in third-gender and PwD electors. National parties secured 63.35% of valid votes, while independent candidates performed modestly, with 7 elected out of 3,921 contestants.

Cabinet Approves Seven Major Schemes to Enhance Farmers' Lives and Livelihoods

On September 2, 2024, the **Union Cabinet, chaired by Prime Minister Narendra Modi**, approved **seven significant schemes** aimed at improving farmers' lives and increasing their incomes, with a total financial outlay of **₹13,966 crore**.

1. Digital Agriculture Mission (₹2,817 crore)

This mission seeks to leverage technology to enhance farmers' lives by establishing a robust Digital Public Infrastructure. Key components include:

Agri Stack:

- Farmers Registry: A comprehensive database of farmers.
- Village Land Maps Registry: Digital records of village land maps.
- Crop Sown Registry: Documentation of crops sown across regions.

Krishti Decision Support System:

- Geospatial Data: Utilization of satellite imagery for agricultural planning.
- Drought/Flood Monitoring: Real-time tracking of weather-related events.
- Weather/Satellite Data: Access to accurate weather forecasts.
- Groundwater/Water Availability Data: Information on water resources.
- Modeling for Crop Yield and Insurance: Predictive analytics for crop yields and insurance assessments.

The mission also aims to integrate modern technologies like AI and Big Data, connect farmers with buyers, and provide new knowledge through mobile platforms.

2. Crop Science for Food and Nutritional Security (₹3,979 crore)

This initiative focuses on preparing farmers for climate resilience and ensuring food security by 2047. Its pillars include:

Research and Education: Advancing agricultural research and education.

Plant Genetic Resource Management: Conservation and utilization of plant genetic resources.

Genetic Improvement for Food and Fodder Crops: Enhancing the quality and yield of food and fodder crops.

Pulse and Oilseed Crop Improvement: Development of high-yielding pulse and oilseed varieties.

Improvement of Commercial Crops: Enhancing the productivity of commercial crops.

Research on Insects, Microbes, Pollinators, etc.: Studying beneficial organisms for agriculture.

The scheme aims to address challenges posed by climate change and ensure sustainable agricultural practices.

3. Strengthening Agricultural Education, Management, and Social Sciences (₹2,291 crore)

This measure aims to prepare agriculture students and researchers for current challenges by:

Modernizing Agri Research and Education: Updating curricula and research methodologies.

Aligning with New Education Policy 2020: Incorporating interdisciplinary approaches.

Utilizing Latest Technologies: Integrating Digital DPI, AI, Big Data, and remote sensing.

Including Natural Farming and Climate Resilience: Promoting sustainable and climate-resilient farming practices.

The initiative aims to equip the next generation of agricultural professionals with the skills needed to address contemporary challenges.

4. Sustainable Livestock Health and Production (₹1,702 crore)

This decision aims to increase farmers' income from livestock and dairy by focusing on:

Animal Health Management and Veterinary Education: Improving animal health services and education.

Dairy Production and Technology Development: Advancing dairy farming practices and technologies.

Animal Genetic Resource Management, Production, and Improvement: Enhancing livestock breeds and productivity.

Animal Nutrition and Small Ruminant Production and Development: Improving nutrition and management of small ruminants.

The scheme aims to enhance the productivity and profitability of livestock farming.

5. Sustainable Development of Horticulture (₹860 crore)

This measure is aimed at increasing farmers' income from horticulture plants by focusing on:

Tropical, Sub-Tropical, and Temperate Horticulture Crops: Cultivation of a variety of climate-specific crops.

Root, Tuber, Bulbous, and Arid Crops: Diversifying crop types for resilience.

Vegetable, Floriculture, and Mushroom Crops: Promoting high-value horticultural products.

Plantation, Spices, Medicinal, and Aromatic Plants: Encouraging the cultivation of specialty crops.

The initiative aims to diversify agricultural income sources and boost overall productivity.

6. Strengthening of Krishi Vigyan Kendra (₹1,202 crore)

This initiative focuses on enhancing the capacity of Krishi Vigyan Kendras (agricultural extension centers) to disseminate knowledge and best practices to farmers, thereby improving productivity and income.

7. Natural Resource Management (₹1,115 crore)

This scheme focuses on the sustainable management of natural resources, essential for ensuring the long-term viability of agricultural practices while also protecting the environment.

One Nation One Subscription

Launched on January 1, 2025, the **One Nation One Subscription (ONOS) initiative** marks a significant advancement in India's research and education landscape. This scheme aims to provide comprehensive access to international scholarly journals and articles for students, faculty, researchers, and scientists across the nation's government higher education institutions (HEIs) and central government research and development (R&D) centres.

The overarching goal is to equip India's academic and research communities with top-tier global resources, thereby fostering innovation and enhancing research quality across various disciplines.

Key Features of the ONOS Scheme

Extensive Access to Scholarly Journals: ONOS offers access to over 13,000 scholarly journals from 30 major international publishers, covering a wide array of disciplines including Science, Technology, Engineering, Mathematics (STEM), Medicine, Social Sciences, Finance, and Accounts.

Beneficiaries: The scheme benefits approximately 1.8 crore (18 million) students, faculty, and researchers across more than 6,300 government-managed HEIs and central government-managed R&D institutions.

Inclusive Access: ONOS ensures equitable access to research resources, particularly for institutions in tier 2 and tier 3 cities, thereby promoting knowledge dissemination across diverse regions.

Implementation and Funding

Centralized Management: The subscription process is centrally coordinated by the Information and Library Network (INFLIBNET), an autonomous inter-university centre under the University Grants Commission (UGC). INFLIBNET manages the distribution of digital access to these journals, ensuring a seamless experience for users.

Digital Access: Journals are accessible entirely through a digital platform, minimizing administrative complexities and providing on-demand access to users.

Government Allocation: A total of ₹6,000 crore has been allocated for the ONOS initiative, covering three years—2025, 2026, and 2027. This funding covers the subscription charges for all participating institutions across the three-year period.

Strategic Alignment with National Goals

The ONOS scheme aligns with India's vision to become a self-reliant and developed nation by 2047, as outlined in the Viksitbharat@2047 roadmap. This initiative is a key component of the roadmap, envisioning India's emergence as a leading global power driven by cutting-edge research, technological advancement, and self-sustained progress.

By providing digital access to over 13,000 journals from 30 international publishers, ONOS bridges gaps in research infrastructure across India. Through its phased implementation, the scheme significantly contributes to enhancing India's academic and research excellence, fostering innovation, and positioning the country at the forefront of global scientific research.

India's 4th Biennial Report to UNFCCC Submitted

India submitted its **4th Biennial Update Report (BUR-4)** to the **United Nations Framework Convention on Climate Change (UNFCCC)** on 30th December, 2024. This report builds upon the Third National Communication (TNC) and provides a comprehensive update on India's National Greenhouse Gas (GHG) inventory for the year 2020. It also includes critical information on national circumstances, mitigation actions, and the associated finance, technology, and capacity-building needs. Union Minister for Environment, Forest, and Climate Change, Shri Bhupender Yadav, highlighted India's leadership in sustainable growth, emphasizing Prime Minister Narendra Modi's commitment to balancing economic progress with meaningful climate action.

Key Highlights of BUR-4 Report

1. GHG Inventory for 2020

- **Total GHG emissions in 2020,**
- **Without LULUCF** (Land Use, Land-Use Change, and Forestry): 2,959 million tonnes of CO₂ equivalent (CO₂e).
- **With LULUCF:** 2,437 million tonnes of CO₂e.
- **Reduction In Emissions:** A 7.93% decrease in total GHG emissions compared to 2019.

2. Sectoral Contributions to Emissions

- **Energy sector:** 75.66% of total emissions.
- **Agriculture:** 13.72%.
- **Industrial Processes and Product Use (IPPU):** 8.06%.
- **Waste:** 2.56%.

3. Forest and Tree Cover Contributions

- Forests and tree cover sequestered 522 million tonnes of CO₂ in 2020, reducing 22% of total CO₂ emissions.
- India's forest and tree cover stands at 25.17% of the total geographical area.

Achievements in NDC's Targets

1. Decoupling Economic Growth Emissions

- Between 2005 and 2020, India's emission intensity of GDP reduced by 36%, exceeding its target of 33-35%.

2. Renewable Energy Progress

- By October 2024, the share of non-fossil sources in installed electricity generation capacity reached 46.52%.
- Renewable power capacity (excluding large hydro): 156.25 GW (4.5 times increase from 35 GW in March 2014).
- Total installed renewable capacity (including large hydro): 203.22 GW.

3. Additional Carbon Sink

- Between 2005 and 2021, India created an additional carbon sink of 2.29 billion tonnes of CO₂ equivalent through increased forest and tree cover.

Commitment to Climate Action

RBI's Guidelines on Government Debt Relief Scheme

The Reserve Bank of India (RBI) has issued detailed guidelines for lenders participating in the **Government Debt Relief Scheme**, aiming to provide structured relief to borrowers facing financial distress. This initiative aligns with the **RBI's ongoing efforts** to enhance financial stability and support economic recovery.

Crux of the Guidelines

The RBI's guidelines outline the framework for lenders to offer debt relief to borrowers impacted by financial challenges. The scheme is designed to facilitate the restructuring of loans, ensuring that borrowers receive the necessary support while maintaining the integrity of the financial system.

Key Components of the Scheme

Eligibility Criteria: The scheme targets borrowers who have demonstrated a consistent repayment history but are currently facing financial difficulties due to unforeseen circumstances.

Restructuring Framework: Lenders are permitted to restructure loans by extending repayment periods, reducing interest rates, or converting a portion of the debt into equity, subject to specific conditions.

Regulatory Oversight: The RBI will monitor the implementation of the scheme to ensure compliance with established guidelines and to maintain financial stability.

Historical Context

This initiative builds upon previous measures taken by the RBI to address financial stress among borrowers. Notably, in 2016, **Hindustan Construction Company (HCC)** became the first firm to receive debt relief under the RBI's Scheme for Sustainable Structuring of Stressed Assets (S4A), which allowed banks to convert a portion of the company's loans into equity or debentures.

Implications for Lenders and Borrowers

For Lenders: The guidelines provide a structured approach to managing distressed assets, enabling banks to offer relief to borrowers while safeguarding their financial interests.

For Borrowers: The scheme offers a pathway to financial recovery, allowing businesses and individuals to restructure their debts and continue operations without the immediate threat of insolvency.

RBI's 2024-25 Report on State Finances

The Reserve Bank of India's (RBI) recent report, "**State Finances: A Study of Budgets of 2024-25**," highlights significant improvements in the fiscal health of state governments post-pandemic, while also identifying areas requiring further attention.

Fiscal Consolidation Achievements

Gross Fiscal Deficit (GFD): States have successfully contained their consolidated GFD within 3% of GDP during 2022-23 and 2023-24, with a budgeted GFD of 3.2% for 2024-25.

Revenue Deficit: Maintained at a low 0.2% of GDP during 2022-23 and 2023-24.

Capital Expenditure: Increased from 2.4% of GDP in 2021-22 to 2.8% in 2023-24, with a further budgeted rise to 3.1% in 2024-25, indicating a focus on developmental spending.

Debt Levels and Liabilities

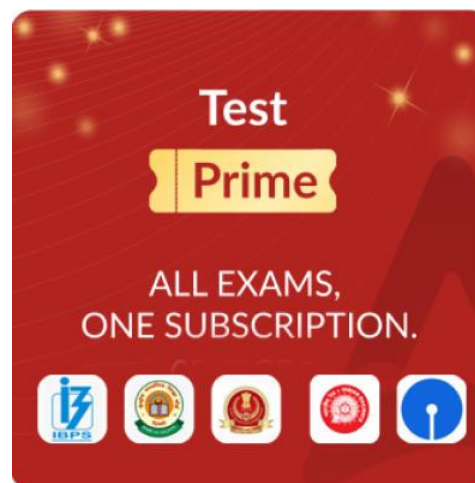
Outstanding Liabilities: Declined from 31% of GDP at end-March 2021 to 28.5% at end-March 2024, yet still above the pre-pandemic level of 25.3% at end-March 2019.

Contingent Liabilities: State guarantees have risen from 2% of GDP at end-March 2017 to 3.8% by March 2023, posing potential fiscal risks.

Subsidy Expenditures

Rising Subsidies: Significant increases in spending on subsidies, including farm loan waivers and free or subsidized services like electricity, transport, and gas cylinders, have been noted. For instance, 14 states have implemented income transfer schemes for women, totaling approximately ₹2 lakh crore, or about 0.6% of GDP.

Power Sector Concerns



Discom Losses: Power distribution companies have accumulated losses amounting to ₹6.5 lakh crore by 2022-23, equivalent to around 2.4% of GDP, despite multiple reform attempts.

Recommendations for Fiscal Sustainability

Debt Consolidation: The RBI emphasizes the need for a credible roadmap for debt consolidation, particularly for states with elevated debt levels, recommending clear, transparent, and time-bound strategies aligned with macroeconomic objectives.

Expenditure Efficiency: States are urged to enhance expenditure efficiency through outcome-based budgeting and to rationalize subsidies to prevent the crowding out of productive expenditures.

Fiscal Framework Reforms: Adoption of risk-based fiscal frameworks with provisions for counter-cyclical policies, along with strengthening State Finance Commissions, is advised to ensure fiscal discipline and adequate fund transfers to local bodies.

Government Forms Committee to Update WPI Base Year

On January 2, 2025, the Government of India established an **18-member committee** to revise the base year of the Wholesale Price Index (WPI) from 2011-12 to 2022-23. This initiative aims to enhance the accuracy of factory-gate inflation measures, reflecting structural changes in the economy over the past decade.

Committee Leadership and Composition

The committee is chaired by Professor Ramesh Chand, a member of NITI Aayog. It includes experts from various sectors, such as economics, finance, and statistics, ensuring a comprehensive approach to the revision process.

Terms of Reference

The committee has been tasked with:

- Commodity Selection:** Identifying commodities for inclusion in the WPI and Producer Price Index (PPI) for the 2022-23 base year, considering structural economic changes.
- Price Collection System Review:** Evaluating and recommending improvements to the existing price collection methodology.
- Computational Methodology:** Proposing computational methods for WPI and PPI.
- PPI Compilation Methodology:** Assessing and suggesting enhancements to the PPI compilation methodology approved by the Technical Advisory Committee on Statistics of Prices & Cost of Living.
- Transition Roadmap:** Developing a plan for transitioning from WPI to PPI.
- Reliability Enhancements:** Recommending measures to improve the reliability of WPI and PPI data.

The committee is expected to submit its final report within 18 months.

Context and Implications

The last revision of the WPI occurred in 2015, updating the base year from 2004-05 to 2011-12. The upcoming revision to 2022-23 aims to incorporate significant economic developments, including the expansion of the service sector, which constitutes over half of India's economic output. Transitioning to a Producer Price Index (PPI) will provide a more comprehensive measure of inflation at the producer level, encompassing both goods and services.

About WPI and CPI and PPI

Wholesale Price Index (WPI)

The WPI tracks the average wholesale prices of goods, focusing exclusively on basic prices, excluding taxes, discounts, transport, and other charges. It is considered a producer-level index, capturing price changes in goods at the wholesale level before they reach consumers. The WPI data is used for GDP deflation, converting nominal GDP into real GDP.

- Scope:** Includes goods, but excludes services.
- Data Release:** Published monthly by the Department of Industrial Policy and Promotion (DIPP), Ministry of Commerce and Industry.
- Function:** Primarily used as a deflator for GDP.

Consumer Price Index (CPI)

The CPI measures retail inflation by tracking the average prices of goods and services consumed by households. It directly impacts government policies like wage revisions, dearness allowances, and inflation targeting by the Reserve Bank of India (RBI).

- Scope:** Includes both goods and services used by consumers.
- Data Release:** Released monthly by the National Statistical Office (NSO), Ministry of Statistics and Programme Implementation.
- Function:** Essential for inflation management, wage adjustments, and economic policy formulation.

Proposed Producer Price Index (PPI)

The PPI is an emerging inflation measure that will capture the wholesale prices of both goods and services at various stages of production. Unlike WPI, it will include the service sector, which plays a crucial role in India's economy and is currently excluded from the WPI. Many developed countries have adopted the PPI as part of the internationally agreed System of National Accounts (SNA) to measure economic activity comprehensively.

- Scope:** Will track both goods and services, unlike the WPI.
- Significance:** It will offer a more complete picture of price changes across the economy.
- Future Adoption:** India is exploring a suitable methodology to transition from WPI to PPI, led by a dedicated Working Group.

Decline in Student Enrolment: UDISE+ Report 2023-24

The Ministry of Education's Unified District Information System for Education Plus (**UDISE+**) report for **2023-24** reveals a significant decline in **student enrolment**, marking a notable shift from the stable figures observed in previous years.

What is UDISE+?

UDISE+ (Unified District Information System for Education Plus) is an online data collection system developed by the Department of School Education & Literacy in 2018-19. It was introduced to replace the manual paper-based data collection process, with improvements in data capture, mapping, and verification.

Key Findings

Overall Enrolment Decline

The total student enrolment decreased to 24.8 crore in 2023-24, a drop of over one crore compared to the previous years. This marks a 6% decline from the 26.02 crore recorded in 2018-19.

Gender-wise Enrolment Trends

Boys: Enrolment fell from 13.53 crore in 2018-19 to 12.87 crore in 2023-24, a 4.87% decline.

Girls: Enrolment decreased from 12.49 crore in 2018-19 to 11.93 crore in 2023-24, a 4.48% decline.

Regional Variations

Bihar: Enrolment dropped from over 2.49 crore in 2018-19 to over 2.13 crore in 2023-24, a decrease of over 35.65 lakh students.

Uttar Pradesh: Enrolment fell from 4.44 crore in 2018-19 to 4.16 crore in 2023-24, a reduction of 28.26 lakh.

Maharashtra: Enrolment decreased from over 2.32 crore in 2018-19 to 2.13 crore in 2023-24, a decline of 18.55 lakh students.

School Infrastructure:

- Over 90% of schools have basic amenities like electricity and gender-specific toilets.
- 57.2% of schools have functional computers.
- 53.9% of schools have internet access.
- 52.3% of schools are equipped with ramps.



Implications

The substantial drop in enrolment raises concerns about the effectiveness of current educational policies and the need for targeted interventions. The data collected through UDISE+ will be crucial in informing future strategies aimed at improving student enrolment and retention rates across various states and demographics.
