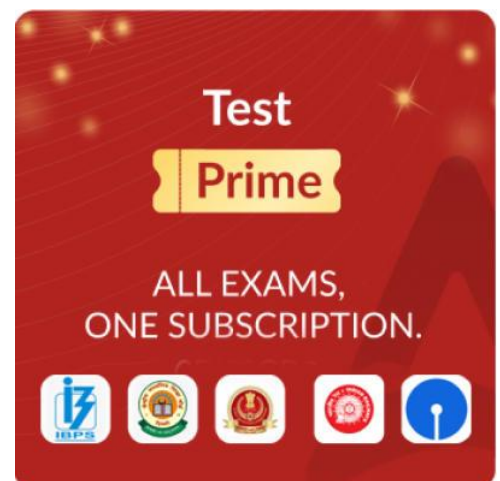

The passage mentions, "**Moreover, the research underscores the rapid adaptability of the gut microbiota to dietary changes, suggesting that even short-term modifications in diet can lead to significant shifts in the composition of the gut microbiota.**"

Therefore, the correct answer is: **(d) Both (I) and (III)** - These statements are supported by the passage, while statement (II) contradicts the information provided about the adaptability of the gut microbiota to dietary changes.

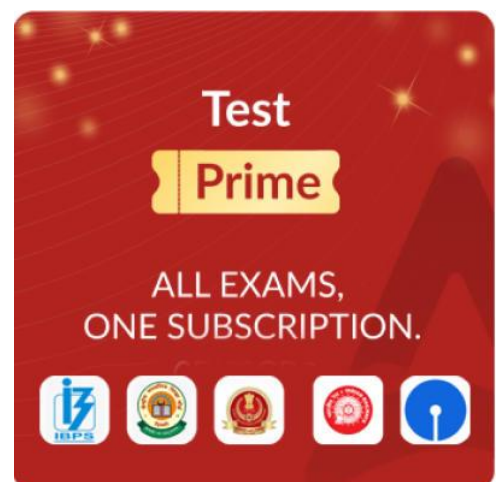
