India – New Zealand Announce Launch of FTA Negotiations

India and New Zealand have officially **launched negotiations for a "comprehensive and mutually beneficial" Free Trade Agreement (FTA)**, marking a significant step in their bilateral relations. This will be India's second FTA in the Oceania region, after the India-Australia Economic Cooperation and Trade Agreement (ECTA), signed in April 2022. The FTA aims to enhance supply chain integration, expand market access, and foster economic resilience and prosperity for both nations.

Key Highlights**Official Announcement**

- The FTA negotiations were announced during a meeting between Indian Commerce Minister Piyush Goyal and New Zealand Trade Minister Todd McClay on March 16, 2025, in New Delhi.

Strategic Timing

- The announcement came ahead of the bilateral meeting between Indian PM Narendra Modi and New Zealand PM Christopher Luxon, who arrived in India for his first official visit.

Current Trade Scenario

- Bilateral trade crossed \$1 billion between April 2024 and January 2025.
- India's exports to New Zealand in 2023-24 were \$538 million, while imports stood at \$335 million, with a \$203 million trade surplus in India's favor.
- In 2024-25 (up to December 31), exports grew by 21.49% to \$496 million, while imports surged by 78.72% to \$463 million, narrowing the trade gap to \$33 million.

India-New Zealand Bilateral Relations: Key Outcomes of PM Christopher Luxon's Visit

Prime Minister of New Zealand, Rt Hon Christopher Luxon, visited India from March 16-20, 2025, at the invitation of Prime Minister Narendra Modi. This was his first official visit to India in his current capacity. During his visit, he engaged in bilateral talks with PM Modi, participated in the 10th edition of the Raisina Dialogue as the Chief Guest, and met with President Droupadi Murmu. **The visit aimed to strengthen bilateral ties across multiple sectors, including trade, investment, defence, education, and multilateral cooperation.** Both leaders reiterated their commitment to enhancing people-to-people ties, maritime security, climate action, and regional stability in the Indo-Pacific.

Key Highlights of the Visit

- PM Luxon received a warm and traditional welcome in New Delhi.
- He laid a wreath at Raj Ghat in honor of Mahatma Gandhi.

- PM Luxon was the Chief Guest at the 10th Raisina Dialogue, delivering the Inaugural Keynote Address.
- Both leaders emphasized strengthening multilateral cooperation and ensuring a stable Indo-Pacific region.

Economic & Trade Cooperation

- Both sides welcomed sustained trade and investment flows and encouraged business collaborations.
- The launch of Free Trade Agreement (FTA) negotiations was announced to enhance economic ties.
- Discussions initiated on digital payments cooperation within the FTA framework.
- The Authorized Economic Operators Mutual Recognition Arrangement (AEO-MRA) was signed to facilitate trade.
- New cooperation on horticulture and forestry was established through MOUs and Letters of Intent.
- Tourism and aviation ties were strengthened, with an update to the Air Services Agreement and plans for direct flight operations.

Defence and Security Cooperation

- Defence cooperation was expanded with the signing of the India-New Zealand MoU on Defence Cooperation.
- Increased participation in military exercises, officer exchanges, and naval port calls.

- New Zealand welcomed India's participation in the Combined Maritime Forces (CMF).
- Both sides agreed on regular dialogue for maritime safety and security.
- New Zealand expressed interest in joining India's Indo-Pacific Oceans Initiative (IPOI).
- Cooperation on the National Maritime Heritage Complex (NMHC) in Gujarat was discussed.

Science, Technology & Disaster Management

- Strengthened partnerships in research, technology, and innovation.
- Focus on low-emission climate-resilient economies and India's leadership in the International Solar Alliance (ISA).
- New Zealand joined the Coalition for Disaster Resilient Infrastructure (CDRI).

Himachal Pradesh Budget 2025-26: A Focus on Tourism, Rural Development, and Green Energy

Himachal Pradesh Chief Minister **Sukhvinder Singh Sukhu** presented the **annual budget for FY 2025-26**, amounting to **Rs 58,514 crore**. The budget emphasizes **tourism, rural development, and green energy**, while also addressing financial challenges such as a **reduction in the Revenue Deficit Grant** and the **withdrawal of GST compensation**.

Financial Challenges and Debt Liability

While presenting his **third budget**, CM Sukhu highlighted the financial difficulties faced by the state. The **Revenue Deficit Grant (RDG)** has been reduced significantly from **Rs 10,949 crore in 2021-22 to Rs 3,257 crore in 2025-26**. Himachal Pradesh has already incurred a **loss of Rs 9,478 crore** till 2023-24 due to the **cessation of GST compensation** by the central government.

The state's **debt liability has risen to Rs 1,04,729 crore**, with **Rs 29,046 crore** borrowed under the present government. Of this, **70% was spent on repaying previous loans and interest**, while only **Rs 8,093 crore** was allocated to developmental projects.

Boosting Tourism: Religious and Eco-Tourism Focus

Tourism has been given a major push in the budget. The government aims to promote **religious tourism and eco-tourism**, as well as explore **lesser-known tourist destinations**. Additionally, **tea estates will be developed into eco-tourism hubs** to attract visitors.

- **Eco-Tourism Expansion:** Seven eco-tourism sites were allocated in 2024, and **78 new eco-tourism sites** will be allocated in the next phase.
- **Revenue Generation:** The government anticipates revenue of **Rs 200 crore over the next five years** through eco-tourism initiatives.

Green Energy and Environmental Conservation

CM Sukhu stressed that **Himachal Pradesh's forest cover acts as the "lungs of North India"** by providing vital ecological services, including **soil conservation, water purification, clean air, and climate stability**. The estimated value of these services is **Rs 90,000 crore annually**. The government is presenting its case before the **16th Finance Commission** to seek financial support for its environmental contributions.

Additionally, the government plans to **purchase 500 electric buses** in 2025-26 to reduce carbon emissions. The **Shimla Ropeway Project** will also be launched in the next fiscal year to promote **sustainable urban transport**.

Support for Farmers and Agriculture

The government has introduced multiple schemes to benefit farmers and agriculturalists:

- **Increase in Milk MSP:**
 1. **Cow milk:** From **Rs 45 to Rs 51 per litre**
 2. **Buffalo milk:** From **Rs 55 to Rs 61 per litre**
- **Natural Farming:** A target of bringing **one lakh farmers** under **natural farming** has been set for 2025-26. So far, **1.58 lakh farmers** have adopted this practice.
- **MSP for Raw Turmeric:** Farmers growing **kachi haldi (raw turmeric)** naturally will receive an **MSP of Rs 90 per kg**.
- **Spice Park in Hamirpur:** The state will set up a **Spice Park** in Hamirpur to boost spice farming and processing.

Employment and Wage Hike

The budget also brings good news for workers engaged in the **Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA)**.

- **Daily wage increased by Rs 20**, from **Rs 300 to Rs 320 per day**.
- Several **new schemes for employment generation** will be introduced, focusing on **rural development and infrastructure**.

Social Welfare Initiatives

CM Sukhu announced several schemes benefiting **pensioners, women, disabled individuals, and children:**

- **Pension Arrears for Senior Citizens:**
 1. Pensioners aged **70-75 years** will receive their **arrears in May 2025**.
 2. The previous **BJP government left liabilities of Rs 10,000 crore** related to government employee arrears.
- **New Directorates for Education:** Separate **Directorates for Schools and Colleges** will be established to streamline **educational governance and policy-making**.

Combating Drug Abuse and Organized Crime

To address the rising concern of **drug abuse** and **organized crime** in the state, the government has announced the following measures:

- **Special Task Force (STF)** to be formed for tackling drug-related issues.
- Introduction of the **Himachal Pradesh Prevention of Continuing Unlawful Activity and Control of Organized Crime Act, 2025**, aimed at preventing illegal activities and organized crime.

Telangana Government Unveils ₹3.04 Lakh Crore Budget for 2025-26: Focus on Welfare and Development

The Telangana Government has presented its most ambitious budget to date, crossing the **₹3 lakh crore** mark for the first time since the state's formation. The budget, which amounts to **₹3.04 lakh crore**, reflects the government's commitment to **welfare programs, economic growth, and infrastructure development**.

Deputy Chief Minister **Mallu Bhatti Vikramarka**, who also holds the Finance portfolio, presented the budget in the state assembly, emphasizing inclusivity and equitable resource distribution. The financial plan outlines significant allocations for **agriculture, education, backward classes, and flagship welfare schemes**, all while balancing fiscal challenges.

Budget Breakdown: Revenue and Capital Expenditure

The Telangana Budget 2025-26 includes:

- **Revenue Expenditure:** ₹2.26 lakh crore
- **Capital Expenditure:** ₹36,504 crore
- **Total Budget Outlay:** ₹3.04 lakh crore (5% higher than last year's ₹2.91 lakh crore)
- **Surplus:** ₹2,738 crore
- **Fiscal Deficit:** ₹54,009 crore
- **Primary Deficit:** ₹34,640 crore

The budget reflects the **state's continued dependence on borrowings**, with an estimated **₹70,000 crore in loans**, including ₹64,539 crore from open market borrowings.

Major Allocations: Welfare and Development at the Forefront
The government has made **massive allocations for various sectors**, particularly for welfare programs targeted at backward classes (BCs), scheduled castes (SCs), and scheduled tribes (STs).

Key Sector-Wise Allocations:

- **Agriculture:** ₹24,439 crore
- **Panchayat Raj (Rural Development):** ₹31,605 crore
- **Education:** ₹23,108 crore
- **BC Welfare:** ₹11,405 crore
- **SC Welfare:** ₹40,232 crore
- **ST Welfare:** ₹17,169 crore

Total allocations for SC, ST, and BC welfare amount to nearly ₹69,000 crore, underscoring the government's commitment to social justice and inclusivity.

Focus on Six Guarantees: ₹56,084 Crore Allocated

A key focus of the budget is the implementation of the **Congress-led government's Six Guarantees**, aimed at social welfare and economic empowerment.

- **Rythu Bharosa (Farmer Support):** ₹18,000 crore
- **Cheyutha (Livelihood and Skill Development):** ₹14,861 crore
- **Indiramma Housing (Affordable Housing):** ₹12,571 crore
- **Mahalakshmi Scheme (Free Bus Travel for Women):** ₹4,305 crore
- **Rajiv Yuva Vikasam (Youth Development):** ₹6,000 crore
- **Scholarships/Stipends for Students:** ₹4,452 crore

Additionally, a **₹11,500 crore subsidy** has been allocated to **reduce power costs** and support **farmers and industries.**

Revenue Receipts and Debt Burden

The Telangana Government expects **revenue receipts of ₹2.29 lakh crore**, sourced from:

- **State Taxes and Duties:** ₹1.45 lakh crore
- **State's Share in Central Taxes:** ₹29,899 crore
- **Grants-in-Aid and Contributions:** ₹22,782 crore
- **Other Non-Tax Receipts:** ₹4,292 crore

However, the state's **debt burden remains a major concern**, with **₹19,370 crore earmarked for debt servicing.** Interestingly, debt repayment in the current year has already exceeded ₹22,000 crore—much higher than the budgeted ₹17,729 crore.

Energy Sector: Yadadri Thermal Power Plant and Electricity Ambulance Service

The **Energy Department** has been allotted **₹21,221 crore**, with a significant focus on:

- **Completing the Yadadri Thermal Power Plant**
- **Launching an Electricity Ambulance Service** to provide **faster and more efficient power services**

This investment is expected to **enhance energy security and improve power supply reliability across Telangana.**

Economic Growth: Telangana's Strong Performance Gross State Domestic Product (GSDP)

- Telangana's **GSDP at constant prices:** ₹16.12 lakh crore
- Growth rate: **10.1% (higher than previous year's 9.9%)**

Per Capita Income

- **Telangana:** ₹3.79 lakh (growth rate: 9.6%)
- **National Average:** ₹2.05 lakh (growth rate: 8.8%)
- **Telangana's per capita income is 1.8 times higher than the national average, indicating strong economic progress.**

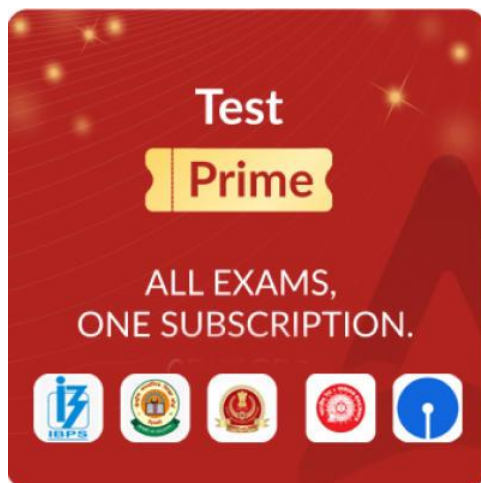

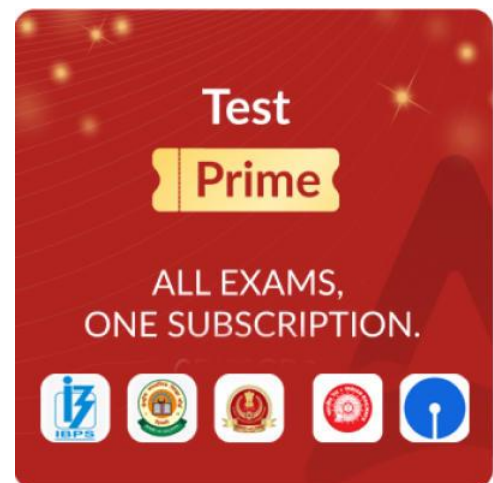
