RECRUITMENT OF ZONE BASED OFFICERS IN JUNIOR MANAGEMENT GRADE SCALE I IN MAINSTREAM ON REGULAR BASIS - DECALARATION OF WRITTEN TEST RESULT

Attention is drawn to our notification dated 20.01.2025 and corrigendum dated 29.01.2025 wherein applications were invited from eligible candidates for the post of Zone Based Officers in Junior Management Grade Scale I (Mainstream) for 266 vacancies in our Bank.

Subsequent to conducting of written examination on 15.03.2025 we are pleased to declare the list of provisionally shortlisted candidates for the interview to the post of Zone Based Officers in JMGS I (Mainstream) in our Bank.

The interviews shall be conducted through VC from 05.05.2025 to 09.05.2025.

Details of interview centre along with Name of Nodal officer are attached as **Annexure E**.

Link for downloading the call letters for interview shall be intimated through a separate Notification.

Candidates are advised to carry original as well as photocopy of Educational, Experience, Caste Certificate, KYC Documents (PAN, Adhar, Passport, Driving License etc.) and all other relevant documents pertaining to their eligibility to the interview center for verification by Bank officials along with iris and biometric verification.

Candidates have to produce 10th/12th standard mark sheet/ certificate evidencing having studied the specified opted local language of the applied Zone as one of the subjects.

Candidates who doesn't have such evidence of having studied the specified opted local language of the applied Zone, have to go through Local Proficiency Language conducted by Bank.

Candidates who do not confirm with the eligibility criteria as specified in Bank's notification of 30.11.2024, shall not be considered.

In case of candidates with **Physical Disability**, the Disability Certificate (40% or above) should be issued by medical board, Persons with Temporary Disability shall not be eligible for Disability benefit of PwBDs.

No TA/DA/ lodging/ boarding etc. shall be paid to candidates for attending the interviews. However, unemployed candidates under SC /ST shall be paid on demand the to and fro train fare of ordinary class on production of valid tickets. They shall not be entitled to any reimbursement of boarding / lodging charges incurred by them for attending the interview.

Candidates are advised once again to check if they are fulfilling eligibility criteria as per notification in all respects. Bank reserves the right to disqualify any candidate who does not fulfill the eligibility criteria at any point of time.

Candidates are advised to regularly visit the Bank's website for updates/ notices/ instructions. All announcements/addendum/ corrigendum/ details pertaining to this process will be only published / provided on authorized Bank's website www.centralbankofindia.co.in from time to time under Career section. No separate communication/ intimation will be sent to the candidates who are not selected/ shortlisted in the process. All notification/ communication placed on Banks's website shall be treated as intimation to all candidates who have applied for the process.

The Bank reserves the right to reject any application/ candidature at any stage or cancel the conduct of interview/GD or to cancel the recruitment process entirely at any stage without assigning any reason.
